

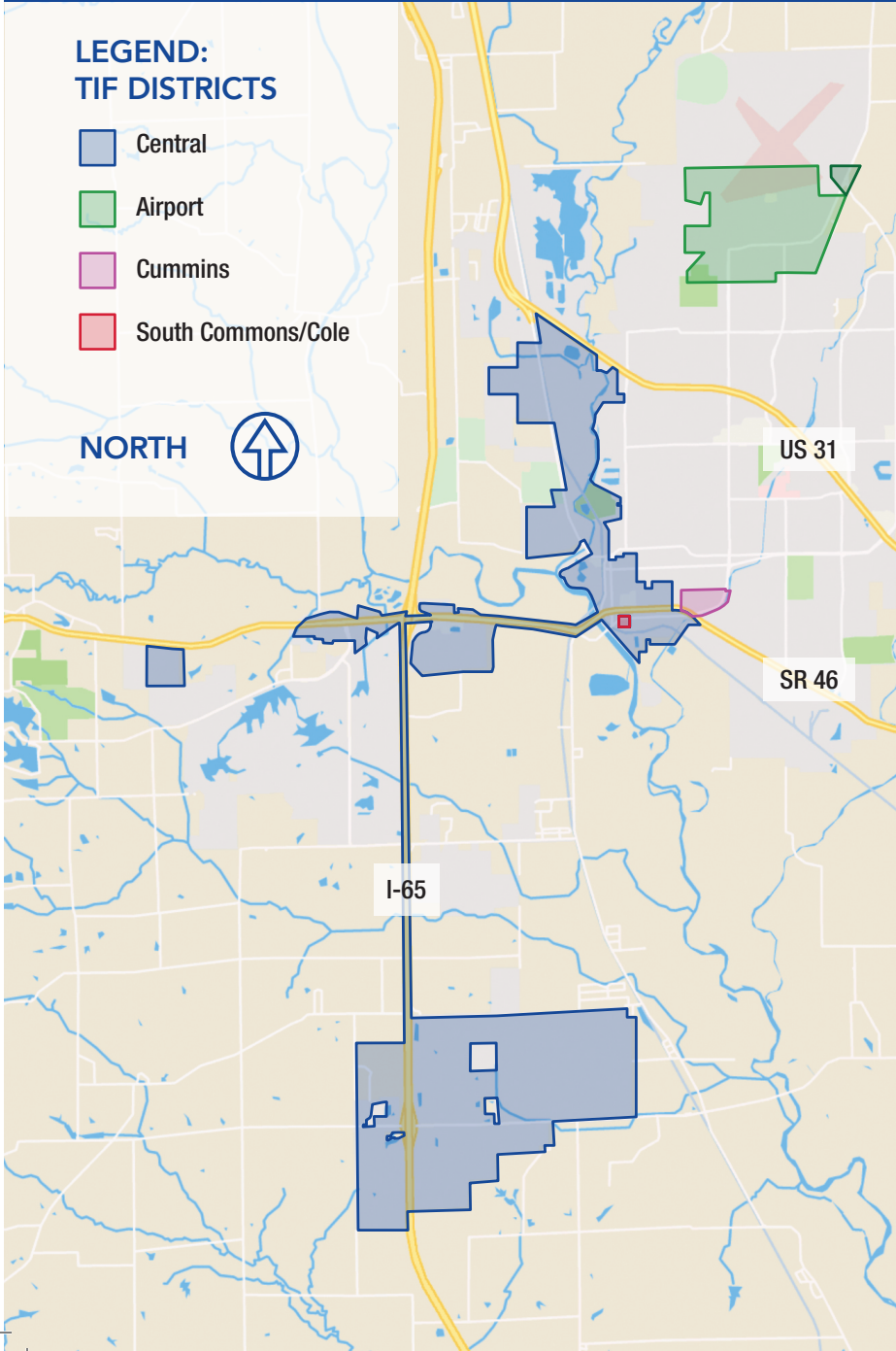
MAP OF TIF DISTRICTS IN COLUMBUS, INDIANA

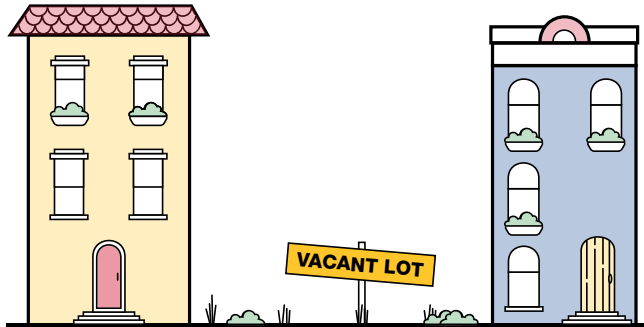

HOW A TIF DISTRICT WORKS TO IMPROVE A VACANT LOT



VACANT LOT IN A TIF DISTRICT

This type of project would impact the “Incremental Assessed Value” during the lifespan of the TIF district described in the chart to the left.



NEW BUILDING

A new project is built on the lot, and the value of the property increases. Through TIF, a portion of the increased value is captured and invested back into the local community.

WHAT PROJECTS CAN TIF FUND?

The purpose of the Columbus Redevelopment Commission as supported by the Redevelopment Department is to execute the Economic Development Plan for the City of Columbus.

The Redevelopment Commission is regulated by Indiana State Code 36-7-14 which designates the duties and powers of the Commission as it relates to how TIF Funds can be used.

CAN FUND

Public Infrastructure, Public Safety Projects, Capital Projects, Recreation Facilities, Workforce Development Grants

CANNOT FUND

Roads, issues affecting our community related to the opioid crisis, and maintenance & operational expenses.
