COMMON COUNCIL COUNCIL CHAMBERS CITY HALL MAY 20, 2025

City Council President Frank Miller appeared in person and called a regular meeting of the City Common Council to order at approximately 6:00 p.m. in Council Chambers.

I. Meeting Called to Order

II. Old Business Requiring Council Action

A. Reading of a Resolution entitled "RESOLUTION NO. 9, 2025, A RESOLUTION ADOPTING A FISCAL PLAN FOR PROPERTY TO BE ANNEXED TO THE CITY OF COLUMBUS, INDIANA." (Sandeep Kumar Bhowra Annexation) Jeff Bergman, Planning Director, presented this Resolution and the following two Ordinances at the same time. He stated that the applicants were requesting an annexation of an approximately seven-acre property, and to rezone the property from AP (Agriculture: Preferred) to CR (Commercial: Regional). Jeff explained the property is located at 3601 West 450 South, near the I-65/SR 58 interchange. He stated that the property is completely surrounded by City limits and therefore meets the contiguity requirements of Indiana law for annexation. Jeff displayed maps and photos of the area. He said that the Columbus Plan Commission forwarded the applications for both annexation and rezoning to City Council with a favorable recommendation by a vote of eight (8) in favor and one (1) opposed. Jeff noted that the applicant intends to use the property for a small-scale truck service center, which would be a conditional use rather than a permitted use within the CR zoning district. He indicated Ann Coriden, representing the applicant, was available for any questions. There were no comments from the public.

D. Second reading of an Ordinance entitled "ORDINANCE NO. 12, 2025, AN ORDINANCE PROVIDING FOR THE ADDITIONAL APPROPRIATION OF FUNDS FROM THE CONSULTING FUND

FOR THE BUDGET YEAR 2025." Jeff Bergman presented this Ordinance. He stated that this additional appropriation was for the Metropolitan Planning Organization (MPO), the entity through which the City receives federal funds to advance transportation improvement projects. Jeff explained that the administrative costs are split 80% Federal, 18% City, and 2% County, and that these administrative funds can be carried over from previous years. The current request is to capture those previously-allocated Federal funds from last year and apply them to other projects for this year. Jeff stated that the City has approximately \$58,000 in Federal funds from last year that could be allocated if the City provides the 20% match, bringing the requested additional appropriation to \$72,488 for the MPO's Consulting Fund. There were no comments from the public. Councilor Miller made a motion to pass the second reading and adopt the Ordinance. Councilor Anderson seconded the motion. Roll call vote as follows:

E. Second reading of an Ordinance entitled "ORDINANCE NO. 13, 2025, ORDINANCE PROVIDING FOR THE ADDITIONAL FROM APPROPRIATION OF **FUNDS** THE INFORMATION SERVICES FUND FOR THE BUDGET YEAR 2025." Jim Hartsook, Director of Technology, presented this Ordinance. Jim stated that the request was for an additional appropriation of \$147,000.00 for transferring the City's Microsoft Office license to Office 365 and to obtain server licensing with Software Assurance. He explained that the current state of these products has an end-of-life of October 2025. Jim also requested \$10,000 for consulting fees to aid in the migration to the new software and servers. He stated that \$36,000 of the requested additional appropriation was for a server management system and password management solution. Brief discussion followed. There were no comments from the public. Councilor Miller made a motion to pass the second reading and adopt the Ordinance. Councilor Anderson seconded the motion. Roll call vote as follows:

F. Second reading of an Ordinance entitled "ORDINANCE NO. 14, 2025, AN ORDINANCE PROVIDING FOR THE ADDITIONAL

FUNDS APPROPRIATION OF FROM THE COLUMBUS REDEVELOPMENT FUND FOR THE BUDGET YEAR 2025." Mikala Brown, Assistant Director of Redevelopment Commission, and Mike Richardson, Director of Security and Risk, presented this Ordinance. Mikala explained the request was for an additional appropriation of \$324,925.00 from the Columbus Redevelopment Fund for operational and maintenance expenses associated with the ownership of the Sears building. Discussion followed. President Miller opened the meeting for public comment. Kerri Sinibaldi asked about the status of the insurance claim for the building. She indicated there were some questions as to the first insurance claim and the possibility of an additional \$25,000 insurance claim if one should arise. She doesn't believe the City should be paying \$50,000 for something that isn't covered. Inaudible response from Mary Stroh, Legal Counsel for the Redevelopment Commission. City Clerk, Luann Welmer, read a prepared statement from John Brian Slater. President Miller closed the public portion of the meeting.
